

# Terms of use for AisView application

## 1. General Provisions

The following text represents an agreement governing the terms of use for AisView application, owned and operated by the Air Navigation Services of the Czech Republic, state enterprise (hereinafter referred to as the "**Operator**"), which is in accordance with the Act No. 121/2000 Coll., the Copyright Act, as amended, entitled to exercise property rights concerning this application. AisView provides graphic information about:

- Airspace and specific objects in LKAA
- Current R&W and NOTAMs in LKAA
- Plans for airspace activation in LKAA (AUP/UUP)
- meteorologic data (OPMET) provided by the Czech Hydrometeorological Institute (hereinafter referred to as the "**CHMI**"), which is also their owner and therefore their copyright holder.

Browsing the website the user of the AisView application agrees to comply with the rules set therein (hereinafter referred to as the "**Terms of Use**"). Should any user violate the Terms of Use, the Operator is entitled to apply measures set in the Terms of Use.

## 2. User Account

Any user, interested in the use of registered parts of AisView application, is obliged to create a user account. Creating a user account consists of creating a user name and password, filling the relevant personal data, reading the Terms of Use and clicking the "*I agree with the Terms of Use*" button located on the registration page.

The Operator is entitled to cancel the User Account if a user is:

- using the AisView application contrary to good morals, laws, regulations and generally accepted ethical and moral principles, and generally accepted rules for use of the services provided via the Internet, or even committing, or assisting crime, or other offenses, misdemeanor, or any unlawful activity,
- using the application for commercial purposes or purposes that can result in any damage to the Operator,
- misusing, blocking, altering or otherwise changing any part of the AisView application,
- attempting disrupt stability, operation or AisView data,
- causing any other damage to the Operator, his authorization or to a third party.

## 3. Data Security & Protection

Personal data provided by a user are considered confidential and will be used only for internal purposes, namely for the purposes of protection of the legitimate interests pursued by the Operator or a third party. The personal data will not be disclosed to any third party or otherwise misused. When collecting the personal data the Operator is subject to the Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).

Creating a User Account, only data necessary for technological security of AisView shall be acquired. The user has the right to request a correction or deletion of personal data (change or cancellation of registration) and to execute other rights according to the General Data Protection Regulation via e-mail sent to aim@ans.cz.

#### **4. Definition of Responsibilities**

The Operator does not guarantee displaying information on user equipment and/or the availability of the website at any time and place. However, the Operator will use its best efforts to remove immediately any reported errors.

The Operator is not in any way responsible for any damages arising from the use of AisView in violation of these Terms of Use or the law.

The use of AisView during pre-flight briefing is the full responsibility of the user.

The AisView website may link to other websites, the Operator is not in any way responsible for the content, availability or any other aspects of such other websites. The information presented on such websites do not express or represent the opinion of the Operator.

The user is responsible for activities associated with the use of AisView. The user claims by logging that AisView will not be used for any activities that could be in conflict with the law or the principles of using the services provided via the Internet.

The user further agrees:

- not to jeopardize or affect the website by computer viruses,
- not to jeopardize a safe use of the website by the Operator or any other user,
- to provide real and true identification and personal data, if required by the Operator.

#### **5. Copyright**

Information provided by AisView may only be used for pre-flight briefings; dissemination or other use is not permitted.

#### **6. Meteo Data**

The source of aeronautical meteorological data (i.e. METAR/SPECI, TAF, SIGMET, warnings) and other additional meteorological data (displayed meteo-radar information, observation of station networks SYNOP and AKS) shall be the Czech Hydrometeorological Institute, a certified provider of aeronautical meteorological services in the Czech Republic and also the owner of the copyright and rights to such data.

All meteorological data are provided for informational purposes, they shall not substitute the prescribed meteorological briefing. Automatically generated meteorological data (AKS stations, SYNOP observations, meteo-radar) are not subject to a manual quality control and their availability is not guaranteed. The interpretation and use of such data is at user's own discretion.

Meteorological data are intended solely for the use of civil aviation; other use and/or further dissemination of such data is not permitted.

## 7. Final Provisions

The Operator is entitled at any time to alter these Terms of Use. Such changes become effective at the moment of their publication on the website, unless otherwise stated herein or on the website.

All disputes arising from the Terms of Use and/or from the use of the website will be governed by the Czech Law.

These Terms of Use comply with this Article and shall apply to the use of mobile devices. The scope of rights and obligations, liability for infringement of copyright or other rights of intellectual property, the responsibility of the Operator and the liability of the Terms of Use, including the possibility to alterations, prorogation and choice of applicable law, is not fully governed by these Terms of Use, regardless of the wording of the previous sentence.

## 8. Technical Requirements

The recommended operating system is Windows.

Internet Explorer 11 (or higher), Mozilla Firefox 45.0 (or higher), Google Chrome 49.0 (or higher) are recommended web browsers. The AisView application has not been tested on other browsers.

The web browser must contain JavaScript support (JavaScript is usually activated in the default installation of recommended browsers).

Due to the efforts to maximize the quality of services provided through the AisView application, it is necessary to perform unscheduled maintenance application. The Operator notifies that the application shall not be accessible during the maintenance time.
